NORTH CAROLINA STATE BOARD OF EDUCATION'S COMPLIANCE COMMISSION FOR ACCOUNTABILITY September 27, 2018

- North Carolina State Board of Education (SBE) policy established the Compliance Commission to serve as an advisory body to the SBE and to make recommendations to the SBE through the NC Department of Public Instruction on testing issues and other issues related to school accountability and improvement.
- Functions of the Council:
 - Consider matters on the following issues:
 - proposed changes to the State's accountability program,
 - the testing code of ethics,
 - test security and administration,
 - * auditing procedures to ensure integrity of the testing and accountability program,
 - the relationship of testing to other aspects of schooling, and
 - other issues related to testing and accountability as deemed appropriate by the SBE
 - Serve as the Appeals Committee of the accountability program, hearing and making recommendations to the SBE on schools appealing the growth standards of the accountability program
 - Consider requests from schools that seek exemption from participating in field test(s) and make a recommendation to the SBE
- Membership: This Commission is composed of twenty-two members, as follows:
 - Four teachers
 - Five principals representing elementary, middle and high schools
 - Four central office staff members (at least one of whom must represent Exceptional Children)
 - > Two members from local boards of education
 - One member from a North Carolina charter school
 - > Two members from the business community
 - One parent representative
 - > One member from higher education
 - > Two at-large members

- The policy notes that, to the extent possible, members will be appointed from the eight education regions to keep the Commission balanced geographically and professionally.
- Terms of membership:
 - Membership shall be four years; terms of members shall be staggered.
 - A member of the SBE as designated by the SBE membership shall sit on the Commission as a non-voting ex-officio member
- The SBE appoints a Commission Chair from its membership.
- The Commission shall meet at least annually. The SBE shall determine if the Commission needs to meet to discuss an issue.
